### 6 Report from EJC 2012

The team from Lublin made a presentation of where they are at with the organization. In addition to organizing the convention, the project is also about spreading juggling in Eastern Europe. As a step on the way the conference on Benefits of juggling has been organized.

The team presented the EJC2012 logo and a map to prove that Lublin is closer.
